WHO CAN ENTER: This contest is open to legal residents of the United States who are 21 years old or older except the employees of the Promoter (**Mann Media/Our State magazine**), the Sponsor (**Sullenberger Aviation Museum**) and members of their immediate families.

HOW TO ENTER: Entrants can submit their information via the Official Submission Form online at ourstate.com. Entries may not be emailed directly, mailed to, or submitted in any other formats to the Promoter. Only one entry is allowed per person.

DEADLINES AND ENTRIES: Entries must be submitted by **February 8, 2025**, at 11:59 p.m. The Promoter reserves the right to contact the entrants.

RESTRICTIONS: Open only to legal U.S. residents (including its territories and the District of Columbia) who are at least 21 years old. - All food and drinks must be enjoyed outside the museum galleries to protect aircraft and exhibits.
- No open flames, balloons, or glitter are permitted inside the museum.
- Alcohol is not permitted anywhere on museum grounds.

WINNER: At the conclusion of the entry period, a winner will be selected at random from all of the eligible entrants. There will be one winner. The selection will be final and binding in all respects. The odds of winning depend on the number of eligible entries received. The winner will be notified by telephone, mail, and/or email. The return of any prize notification as undeliverable or the non-response to any prize notification will result in the disqualification of the entrant and the selection of an alternate winner. In the event of a dispute about the identity of an entrant, each entry will be declared made by the authorized account holder of the email address submitted at the time of entry. The authorized account holder is defined as the natural person who is assigned to an email address by an Internet Service Provider, online-access provider, or other organization (e.g., business, educational institution, etc.) that is responsible for assigning email addresses for the domain associated with the submitted email address. With respect to each winning entry, the winner may be required to provide proof that the winner is the authorized account holder of the email address associated with the winning entry. Entrants agree to be bound by the Official Rules and agree that if the winner fails to provide proof of identity, fails to provide required affidavit, is found to have violated the Official Rules, or otherwise does not meet eligibility criteria, the prize will be forfeited and awarded to an alternate winner in a random drawing.

NO TRANSFERS: No transfers, substitutions in prizes, or cash will be allowed except by the Promoter, which may substitute a prize of equal or greater value. The Promoter reserves the right to modify or terminate this contest or disqualify any entry in the event of technical impairment by computer viruses or otherwise. In the event of early termination, the Promoter will randomly select a winner from all eligible entries received at the time of termination. The Promoter is not responsible for Internet crashes or slowdowns caused by network congestion, viruses, sabotage, satellite failures, phone line failures, electrical outages, natural disasters, or acts of man or God.

LIMITATIONS OF LIABILITY: The Promoter is not responsible for: (1) lost, late, misdirected, undeliverable, or incomplete entries due to system errors or failures, or faulty transmissions, or other telecommunications malfunctions and/or entries; (2) technical failures of any kind; (3) failures of any of the equipment or programming associated with or utilized in the contest; (4) unauthorized human and/or mechanical intervention in any part of the entry process or the contest; (5) technical or human error that may occur in the administration of the contest or the processing of entries; or (6) any injury or damage to persons or property that may be caused, directly or indirectly, in whole or in part, from an entrant's participation in the contest or receipt or use of any prize.
